JPEG or TIFF images or photos inserted into Microsoft Word documents should also be sent as separate files. In the interest of clarity and brevity, DISAM reserves the right to make minor editorial changes to articles submitted for publication.

Send all articles, photos, and/or items of information intended for the Summer issue, with any necessary clearance and approval, to DISAM/DR, via internet, [managingeditor@disam.dsca.mil](mailto:managingeditor@disam.dsca.mil) or [editor@disam.dsca.mil](mailto:editor@disam.dsca.mil); or mail information to DISAM/DR by 1 June 2003. Other quarterly DISAM suspense dates are 1 September, 1 December, 1 January, and 1 March each year. It is DoD policy that all information prepared by DoD employees be reviewed for clearance by appropriate security review in public affairs offices.
